We are responsible for servicing your tank but after the gas leaves the service valve on the container it is the customer's responsibility that the gas line and all appliances are kept in a safe working condition. We have no control over how you use your gas system. Be very careful who works on your appliances and gas line. Make sure that work performed on your system is done by a LICENSED contractor and that a "Gas Check" with a pressure test be performed, recorded and signed by the service personnel that is doing the job. As added insurance, we recommend you obtain a propane gas detector in the unlikely event a leak develops at a later date.

Rights of Ingress and Egress: Customer grants Central Propane Co Inc. free ingress and egress from the premises for the purpose of construction, inspecting, repairing, delivering gas and any other purpose necessary in providing gas service. Customer will not hold Central Propane Co Inc. (CPC) responsible for any kind of damages to driveways of any kind including easements.

In the event credit is extended to Applicant, Applicant agrees that interest at 1 ½ percent shall be added to any outstanding balance owed thirty (30) days, until paid. Further, in the event CPC brings legal action to collect money owed, Applicant shall be responsible for all attorney's fees and court costs incurred by CPC.
